The first round of screening may be done with the online application and then the shortlisted applications may be contacted through the mail to submit the hard copy through proper channel. #### **General terms and conditions**

- 1. The innovation should be new, novel and original.
- 2. The proposed innovation should be science and technology oriented.
- 3. The applicant seeking financial support should apply in the specified format with necessary details.
- 4. The applicant(s) may be an individual or a group of people from Tamil Nadu.
- 5. The applicant must apply through any higher educational institution (Working in the relevant field) for collaboration works, should get the declaration form signed from the head of the institution
- 6. The applicant should submit the declaration form in scanned copy through the Google form. Need not send any hard copy to the council while applying. After shortlisting the applications the shortlisted applicant may be contacted through the mail to submit the hard copy through proper channel.
- 7. The applicant(s) should not apply/seek any funding support from any funding agency for the same innovation.
- 8. The applicant should not have availed any other funding support previously for the same innovation from any agency.
- 9. The innovations will be short-listed, evaluated and selected through the expert committee.
- 10. The selected potential innovation may be supported financially as recommended by expert committee with maximum of Rs. 1,00,000/- (one lakh) only.
- 11. Council will facilitate the innovation by way of financial/technical support for its successful development as a prototype/product.
- 12. Council will also facilitate to protect the innovation under suitable Intellectual Property Rights. However the applicant should bear the cost involved for the same.
- 13. The council provides facilitation services for IP filing, and is not responsible for any adverse actions and hence cannot give assurance for grant/registration of an Intellectual property.
- 14. The identified potential innovation selected will be associated with suitable mentor in any one of the institution/industry as desired by the expert committee.
- 15. The short-listing, evaluation and selection of innovation by the expert committee are final and further consideration or any other communication in this regard will not be considered.

- 16. The financial support is provided only for the particular innovation and its development as proposed.
- 17. The applicant may be invited to present before the expert committee, if needed. Kindly note that the travel expenses and other expenses should be borne by the applicant.
- 18. Penal action will be initiated against the applicant for wrong information, copying of others' innovation and misuse of funds approved by the council if found at any stage.
- 19. If an applicant availed financial support under this scheme in a year, the same applicant is not eligible to avail the support for next two years i.e, applicant is eligible to avail this support once in three years.
- 20. The applicant should strictly follow the timelines as prescribed by the council, to provide any required additional details.
